II Terms of Reference:-

The Committee shall monitor and resolve issues related to implementation of the scheme at the State Level. Implementing the scheme for assigning a Unique Identification Number for every resident in Himachal Pradesh requires assistance with regard to:-

- i) Providing Logistics Support (Office space, Housing etc) in the initial stage of setting up of the State Unit of UIDAI.
- ii) Providing of authenticated list of Villages in the State.
- iii) Providing of authenticated list of Panchayats (As per the latest delimitation of Constituencies) in the State.
- iv) Providing of data base of ration card (PDS).
- v) Providing of BPL data base.
- vi) Providing of information on any other data base that may be relevant for this project.

III. Nodal Department:-

The Planning Department will be the Nodal Department for coordinating the activities related to UID on behalf of the State Government. The Coordinating Officer for UID will be the Adviser (Planning).

IV. The Committee will hold its meetings month/quarterly basis as per requirement.


