1. Nodal officer shall regularly monitor complaints pertaining to his/ her department/ district on the Mukhya Mantri Seva Sankalp Helpline. The nodal username and password may be obtained from Department of IT, H.P.

- 2. The Nodal Officer shall ensure the timely redressal of complaints received in his/ respective department/ district through MMSS Helpline.
- 3. The Nodal Officer shall monitor the list of defaulter officer (who has not taken any action in the stipulated time on the complaints received to them on Mukhya Mantri Seva Sankalp Helpline) and take further necessary action.
